Supplier Registration Tutorial – If you already have an SAP Ariba account



ATTENTION: The Ariba platform has two types of accounts: Standard and Enterprise. Only the Standard account is completely free. Remember that if you log in with an existing account and that account is not an Ariba Standard account, fees for using the portal may apply to your transactions.

Enterprise accounts are subject to fees for using the portal. If you have a Enterprise account and do not want to associate Usiminas registration with it, you must create an account of the Standard type.
